— Before sending your submission, please ensure that it complies with the specifications outlined below. Please note too that we need a full contact postal address in order to register a submission.

SUBMISSIONS CRITERIA

Submissions should focus on new research. They may be sent to the Editors at any time throughout the year and should normally be of the following kinds:

- Articles of up to 15,000 words (the word-count to include footnotes)
- shorter Notes of a miscellaneous character
- editions or transcripts of previously unpublished texts and documents (these are normally published as appendices to Articles or Notes)

Cluster submissions will be considered on a case-by-case basis. Please address an enquiry to the Editors in the first instance.

Please note:

— Submissions must be original and not previously published or due to be published elsewhere, whether in greater or lesser detail or in the same or another language.

— The *Journal* does not solicit contributions, nor can the Editors consider proposals for articles or unfinished drafts.

— Similarly, the Editors cannot accept submissions which require extensive editorial input such as further research or rewriting, or creative input such as the production of print-quality diagrams.

— Submissions should be in English. Quotations in other languages should normally be translated or summarised in the text, with a footnote giving the original in full. (See our Style Sheet.)

— Authors are reminded that the *Journal* is intended as an interdisciplinary historical forum. Papers should be comprehensible not only to specialists in a given area of expertise but also to other scholars who may

be interested in research which touches on their own, related historical field.

— Prospective contributors are asked to adhere to *Journal* conventions. For example, in keeping with our emphasis on new research, usually from primary sources, discussion of recent historiography should be confined as far as possible to the footnotes.

— It is preferred that submissions respect at least the basic principles of *Journal* style. Please note, for example, that papers published in the *Journal* do not contain bibliographies: references should be cited in footnotes in accordance with our Style Sheet.

— All texts should be sent as both PDF and Word files; only the (anonymised) PDF file, however, will be sent out to peer reviewers. The text and footnotes should be presented in double line-spacing. Each page should be numbered and should bear a key word of the title.

— Illustrations should be submitted as a single PDF file, presenting all the images together with their numbered captions (corresponding with Fig. numbers within the text). Note that the caption should include the provenance of the original object.

— To facilitate our standard ‘double-blind’ review process, the PDF files submitted to the Editors should not contain information that identifies the author(s).

— Small files may be sent by e-mail to jwci@sas.ac.uk, but files which contain images are often too large to be sent as e-mail attachments: these should be sent using an internet-based file transfer facility or, if necessary, provided on a transportable device.

— It is always assumed that authors have retained an appropriate copy of their work.

CONDITIONS OF PUBLICATION

Submissions which are accepted for publication will need to be put fully into the *Journal*'s house style.

Where required, it is the author's responsibility to provide suitable illustrations for publication (see the specifications below), to obtain permission to reproduce them and to pay any copyright fees.

Acceptance of a contribution for publication in the *Journal* implies formal transfer of copyright including electronic rights in that contribution to the Warburg Institute for publication in the *Journal* or any reprint thereof. The Editors will, however, normally grant permission to an author, author's agent or executors

for a contribution to be reprinted elsewhere after its appearance in the *Journal*.

Journal authors are not paid but are allocated access to the online edition (ISSN 2044-0014) hosted by IngentaConnect™ for the volume in which their contribution is included, from which PDF copies can be downloaded without charge.

Authors of Articles but not of Notes or of Cluster component papers will receive a complimentary copy of the printed volume, and all authors are entitled to purchase copies of the issue at a reduced rate.

Currently authors of Articles and Notes receive 12 bound offprints free of charge and authors of Cluster component papers receive 6 bound offprints of the entire Cluster free of charge; any offprints promised in return for favours granted or in lieu of copyright fees must come out of the author's own allowance. Additional offprints may be ordered at an author's own expense, provided an order can be placed with our printers in good time; further details including prices will be provided shortly before publication. Please note, however, that the offprint allowance is likely to be discontinued in future: this issue is under review.

Our Policy on Open Access Self-Archiving of articles accepted for publication can be found separately on the *Journal* website.

NOTES ON SUPPLYING ILLUSTRATIONS FOR PUBLICATION

It must be stressed that only professionally produced images are suitable for publication in the *Journal* and that scanners, digital cameras and image-manipulation software cannot guarantee high quality image files for lithographic printing: however great their range of functions, it is no substitute for the knowledge, optical judgement and experience of the professional photographer. Similarly, drawings and diagrams must be properly produced, reflecting the function of all images in the *Journal* as integral parts of the argument.

Images with tonal variety:

This category describes the majority of *Journal* illustrations. We require clear, critically sharp, well-lit photographs with detail from shadow to highlight, made directly from the work to be reproduced.

— We are able to include a limited number of colour images in each volume. Due to financial constraints, we are obliged to limit this facility to papers for which colour reproductions are likely to enhance comprehension of the subject matter.

— The file size for an acceptable digital image is normally at least 1 megabyte, rising to much larger for complex colour images which show, e.g., paintings, fine drawings, folios from illuminated manuscripts, or texts with marginal and interlinear annotations.

— Where images have to be obtained from archives or libraries it is advisable to order them in good time, as there is sometimes a long waiting list, particularly

over the summer. Some image archives may specify pixels measurements: a width of around 2000 pixels is the most suitable for a full-page reproduction.

— Photographic prints should be clearly marked with their Figure numbers on the reverse, using a soft pencil: do not type or write heavily as the marks may show through when the print is subjected to bright light, prior to printing. Any photographic prints will be returned after the *Journal* has been published.

Images where the original object cannot be photographed:

Very occasionally, it may be necessary to scan a printed reproduction from a published book. In such cases, authors are asked to contact the Warburg Photographic Collection, who will normally scan the image directly from a book in the Institute's Library, thus ensuring that the digital file will be of the quality we require.

— If better copy for any illustration exists in a book or manuscript not available to the contributor, this should be noted in a full bibliographical reference.

Line drawings done by hand, and diagrams produced using specialised software:

— Line art which was generated digitally should be supplied as a large, high-resolution digital file. The dimensions should correspond with the diagram's anticipated publication size (a past copy of the *Journal* will serve as a guide). Please note that desktop printers are unreliable for proofing fine lines, because they usually have a minimum dot dimension (and therefore a minimum line width, which can be misleading).

— In the case of ink drawings, we prefer to work from the original, or a clear photograph of it printed on gloss finish paper, rather than a photocopy.

Copyright for images published in the Journal:

When requesting permission to reproduce images, it is worth stressing that the *Journal* is a purely academic, scholarly periodical and that authors are not paid for their contributions. Some copyright holders may waive or reduce their usual fee in this circumstance; but it may be necessary to request specifically that they do so. Note too that archives or museums which supply photographs will normally ask for an offprint when the article is published (but some, such as the British Library, already receive copies of each volume).

— The following information may be required by copyright holders: ISSN 0075-4390, online ISSN 2044-0014; print run 1500; the *Journal* is published in English only, but has subscribers worldwide.

— When, exceptionally, an image has been scanned from a published book, it remains the contributor's responsibility to negotiate reproduction permission with the owner of the copyright for that image.

— Authors should be aware that when illustrations or diagrams are to be published by the author as Open Access, additional copyright clearance and associated payments may be required.
